Event Information :

- Entries with tracking may be limited due to tracking field availability.
- **TENATIVE SCHEDULE:** Schedule subject to change depending on entries. Updates will be emailed
Tracking begins at 7:30am on Saturday at Prado. Please arrive at 7:00. A \$15 Parking fee will be required for entry to the park.
Obedience and protection will begin at the Compton field following the completion of tracking.
- Hospitality: Complimentary coffee, water and doughnuts will be provided at tracking.
It's recommended to bring your own lunch as there are limited options for purchase in the area.
- USCA Covid-19 guidelines will apply on trial day. Please bring your own face covering.

Dog Information :

- All dogs must be identified by microchip or tattoo with at least 4 legible characters
- Proof of your dog's vaccination may be required. Please bring a copy of current rabies certificate and other vaccinations to the trial.
- Dogs must be on leash on the trial site and surrounding property unless on the trial field performing off-leash exercises.

Handler Information :

- Please bring the following to the trial:
 - Membership card
 - Score book (Only 1 score book per dog. No bonds for non-USCA members.)
 - Dog's vaccination records
 - Shade for your vehicle/dog(s) in case of warm weather
 - Water for your dog
- For BH entries, if this is your first test, you will be required to take a written test.
- Please park in designated areas and pick up after your dogs. Do not allow dogs to urinate on buildings, fencing, decks or vegetation around the buildings
