#### Release, Waiver of Liability and Indemnity Agreement:

I hereby acknowledge that I have voluntarily applied to participate in activities sponsored by <u>Rocky Mountain Working Dogs</u> (hereby referred to as RMWD or as the "CLUB"). Being held on the property of <u>Janelle Schrag</u> and <u>Lauren Anema located at 30200 County Road 5</u>, <u>Elizabeth</u>, <u>Colorado 80107</u> (hereinafter referred to as the "SCHRAG TRAINING FACILITY"), at the property of Ken and <u>Laurie Stupak located at 32800 East 137th</u> Way in <u>Brighton</u>, <u>Colorado (hereinafter referred to as the "STUPAK TRAINING FACILITY")</u> as well as at Classic Turf Sod Farm located at 30101 East 152nd Avenue in <u>Brighton</u>, <u>Colorado</u> (hereinafter referred to as "<u>TRACKING GROUNDS</u>").

I hereby agree that under no circumstances shall I prosecute or present any claim against Janelle Schrag and Lauren Anema, Ken and Laurie Stupak, the <u>CLUB, THE SCHRAG TRAINING FACILITY, THE STUPAK TRAINING FACILITY AND/OR TRACKING GROUNDS</u> forany causes of action for personal injury, property damage, or wrongful death, whether the same shall arise by negligence or unintentional conduct of anyone participating in the activities sponsored by the CLUB or any pursuit incidental thereto. This Agreement shall bind the members of my family and my spouse, heirs, assigns, and personal representatives, and shall be deemed as a RELEASE, WAIVER, AND DISCHARGE OF LIABILITY, AND COVENANT NOT TO SUE Ken and/or Laurie Stupak, the <u>CLUB, THE SCHRAG TRAINING FACILITY, THE STUPAK TRAINING FACILITY AND/OR TRACKING GROUNDS</u>. This agreement does not restrict my rights in regard to actions against the <u>CLUB</u>.

I understand and agree that I shall be personally responsible for my own safety in participating in the activities sponsored by the CLUB and assume all risks and accept full and complete responsibility for any and all damages and personal injury of any kind, including death.
