Directions:

From the North: take I-81 South, exit Route 9 East (Charles Town), and take the exit Leetown, Kearneysville and go onto Leetown Rd towards Leetown (right after the ramp).. Go app. 4 miles, go through Leetown and make the first right onto Sulphur Springs Road. Go app. 0.8 miles and make a right onto Egypt Rd. The trial field is 0.1 miles on the left

From the South: take I-81 North, exit Route 9 East (Charles Town), and take the exit Leetown, Kearneysville and go onto Leetown Rd towards Leetown (right after the ramp).. Go app. 4 miles, go through Leetown and make the first right onto Sulphur Springs Road. Go app. 0.8 miles and make a right onto Egypt Rd. The trial field is 0.1 miles on the left

From the East: take either I-70 (Baltimore) or I-270 (Washington, DC) towards Frederick, MD. Go onto Rt. 340 West (Charles Town). Exit onto Rt. 9 West; Go app. 4 miles and take the exit Leetown, Kearneysville and go onto Leetown Rd towards Leetown (left after the ramp).Go app. 4 miles, go through Leetown and make the first right onto Sulphur Springs Road. Go app. 0.8 miles and make a right onto Egypt Rd. The trial field is 0.1 miles on the left
