- HDWD will provide beverages and snack items throughout the day including lunch for a nominal fee. We may or may not break for lunch.
- Please park in designated areas and pick up after your dogs. Do not allow dogs to urinate on buildings, fencing, decks or vegetation around the buildings.
- Bring shade for your vehicle/dog(s) in case of warm weather.
