In accord with the park's department policies, all socially distant spectators are welcome.

In accordance with UScA's Covid-19 Relevant Policies:

- 1. "Clubs, officials, participants, and spectators are required to follow and comply with federal, state, local and facility guidelines that apply to the area and site where the event is held".
- 2. Bring your own masks or other face coverings, hand sanitizer, gloves and tissues. The hosting club might not provide these items.
- 3. Competitor parking will be separate from spectators at the training field to facilitate social distancing.
- 4. Before the trial begins <u>if the handler has their own dumbbells (all levels) they</u> <u>can use them</u>. Ensure they are marked with the handler's name and given to the trial secretary. If they do not have their own dumbbells the club must provide disinfected dumbbells between dogs.
- 5. Throughout the trial, competitors should wear a face covering and gloves (they may be any type, i.e., training gloves, etc.) To help assure your dog's success, it is advised that you expose the dog to people wearing masks.
- 6. The group must maintain minimum distance of 12 feet from each other, and wear mask and/or face shield. Handler may stop in the middle of the group maintaining the 6 foot distance.
- 7. Both handler and helper must wear masks and gloves during the **protection** routine.
- 8. After taking the stick from the helper, the side transport is performed normally.
- 9. Handler reports out maintaining 6 feet distance away from the judge.
- 10. The stick may be given back to the helper or lay it on the ground after reporting out.
- 11. All competitors must sign and submit the UScA's waiver agreement which is located below.
- 12. All spectators are urged to wear masks and gloves in addition to socially distancing from all others.

ASSUMPTION OF RISK / WAIVER OF LIABILITY / INDEMNIFICATION AGREEMENT

In consideration of being allowed to participate in Mid-Rivers Schutzhund Club, the United Schutzhund Clubs of America events and activities, the undersigned acknowledges, appreciates, and agrees that:
