**SOUTHWEST OHIO SCHUTZHUND CLUB LIABILITY WAIVER AND RELEASE**

By entering and/or participating in a Schutzhund trial, training, practice and/or related activities or events, including any social activities or events, sponsored by Southwest Ohio Schutzhund Club (collectively, the "Trial"), and signing this Liability Waiver and Release (this "Release") as a dog owner, dog handler, parent or guardian, official, volunteer or other participant in the Trial, and in consideration of the opportunity to participate in or be present at the Trial:

**I AGREE** that participation in or presence at the Trial and dog sport activities in general involves inherent risks of accident, loss, harm, severe bodily injury and even death to dog and/or dog owner, dog handler, officials, volunteers, spectators or other participants in the Trial and, with full knowledge of these inherent risks, I voluntarily choose to attend the Trial. I hereby accept full responsibility, financial and otherwise, for the actions and inactions of myself, my family and guests and my dog(s) related in any manner to the Trial.

**I AGREE** that all dogs, equipment, supplies, vehicles and other property belonging to or accompanying me are under the care, custody, supervision and control of myself and that the property owners and sponsors of the Trial are not insurers of my dog(s), equipment, supplies and other property and are not liable for any loss, damage, destruction, theft or any other interference with my property rights. I will maintain control of and be responsible for the welfare of my dog(s) during the Trial. I further acknowledge that I am responsible for insuring myself, my dog(s), my property and my belongings against any theft, loss, injury or damage that may be sustained as a result of my participation in or presence at the Trial.

**I RELEASE** and forever hold harmless Southwest Ohio Schutzhund Club, its officers, directors, members, guests, agents, spectators, entrants, judges, officials, volunteers, Henderson Turf Farm, Inc., property owners where any phase of the competition or training may be held, and other participants in the Trial, and their successors and assigns (collectively, the "Released Parties"), on behalf of myself, my family, my agents, fiduciaries and assigns, from any and all claims that may arise, for money damages or otherwise, including but not limited attorney fees, for any harm, injury, disease, damages or loss to me, my family, my guests or my dog(s) during the course of, or as a result of, our participation in or presence at the Trial, even if the harm resulted directly or indirectly from the negligence of the property owners, sponsors, or their agents, and expressly assume all risks of any such harm.

**I RELEASE**, assume the risk of, and indemnify the Released Parties, from any and all claims that may arise, for money damages or otherwise, for any harm, damages, injury, loss or other claims caused, in whole or in part, by the actions or inactions of myself, my family, my guests or my dog(s) during the course of, or as a result of, our participation in or presence at the Trial, even if the harm resulted, in part, from the direct or indirect negligence of the Released Parties.

**I AGREE** that Southwest Ohio Schutzhund Club may create, use or publish photographs, audios, videos, or other likenesses of me and/or my dog(s) taken during the course of the Trial, provided that no direct compensation is received therefore, and I hereby expressly and irrevocably waive and release any and all legal or equitable claims or rights that I may have in connection with such use, including any claim for compensation or other damages, invasion of privacy, right of publicity, or misappropriation.

**I AGREE** that in the event of an emergency, Southwest Ohio Schutzhund Club may, in its sole and absolute discretion, authorize medical treatment to be provided to myself, my family and/or my dog(s).

**I UNDERSTAND AND AGREE** that this event will be conducted in accordance with the current rules and regulations of the United Schutzhund Clubs of America (USCA) and I agree to abide by these rules and regulations. I further agree to abide by club and event rules and regulations. I understand and agree that the Club and/or the trial judge has the right to dismiss any dog or handler for violation of the rules and regulations or for unsportsmanlike or potentially dangerous conduct. In the event of such dismissal, entry fees will not be refunded. I hereby release and forever hold harmless the Released Parties and USCA for any action taken to establish and/or enforce their rules and regulations.

**I REPRESENT** that I am either eighteen (18) years of age or older and that I have the legal capacity necessary to enter into a binding contract under the laws of the State of Ohio, or that I am the legal parent or guardian of the minor child named below. If I am the parent or guardian of a junior handler or other participating minor child, I consent to the minor child's participation in or presence at the Trial, and **I AGREE** to assume all obligations under this Release on the minor child's behalf.

**I ACKNOWLEDGE** that I have been advised to read this Release carefully before signing. I further acknowledge that I have the right to consult with an attorney of my choosing before signing and that I have either consulted with such an attorney or hereby waive my right to do so. I further acknowledge that by signing this Release I am waiving certain legal rights, including the right to sue. I have read and understand the terms of this Release and voluntarily sign this Release of my own free will.
