Greg trained his dog, "Flair" (L'Flair of Vitosha SchH3, IPO3), from a puppy to achieving SchH III and IPO III several times. He has represented the USA three times at the FMBB Malinois World Championship (2006, 2007 and 2008). He won the 2007 Southeastern Regional Schutzhund III Championship with a V score of 289 (95/95/99), High in Trial, High HOT, and High Alternate Breed.

Flair finished second at the 2007 AWMA IPO III National Championship when he was seven years of age. He earned the AWMA IPO III High in Protection Award two times (2005 and 2007) and earned a perfect score of 100 in a SchH III protection performance at the Empire Working Dog Club trial.

As a coach, Greg is known for his clear and concise communication style. His skill at both reading and training dogs allows him to adjust a training program to fit a particular problem and give feedback to the handler to help him succeed. As a national level competitor and coach he is able to give good advice across 2 of the 3 phases of IPO; obedience and protection.

Greg is certified as a National Level Trial Helper with the United Schutzhund Clubs of America. In 2009, he served as front half helper for the American Working Malinois Championship. He has decoyed for numerous police patrol dogs and graduated from Advance Canine Academy's patrol and narcotics police dog school in 2004.

The long weekend will help participants gain the most out of the seminar experience and allow Greg the opportunity to work with each dog. There is a limit of 12 dog/handler teams that will be able to participate although we can take up to 40 non-working participants.

Cost: \$350.00 per working team (1 handler /1 dog) for three days or \$150 per day.

Observer fees are \$75.00/day or \$150.00 for all three days.
