I hereby agree that under no circumstances shall I prosecute or present any claim against Carlo Alberto and/or, the CLUB, CNYWDC TRAINING FACILITY AND/OR TRACKING GROUNDS for any causes of action for personal injury, property damage, or wrongful death, whether the same shall arise by negligence or unintentional conduct of anyone participating in the activities sponsored by the CLUB or any pursuit incidental thereto. This Agreement shall bind the members of my family and my spouse, heirs, assigns, and personal representatives, and shall be deemed as a RELEASE, WAIVER, AND DISCHARGE OF LIABILITY, AND COVENANT NOT TO SUE Carlo Alberto and/or the CLUB, THE CNYWDC TRAINING FACILITY AND/OR TRACKING GROUNDS. This agreement does not restrict my rights in regard to actions against the CLUB.

I understand and agree that I shall be personally responsible for my own safety in participating in the activities sponsored by the CLUB and assume all risks and accept full and complete responsibility for any and all damages and personal injury of any kind, including death.
